## **Recommendations**

It is recommended that:

- The proposal in the amount of \$233,910.00, including HST for the Wyandott Street Reconstruction, Community of Chatham be awarded to RC Spencer Associates Inc.
- 2. The Mayor and Clerk be authorized to sign the necessary agreement.

#### **Background**

The Municipality of Chatham-Kent is experiencing operational and condition issues with the existing sanitary sewers along Wyandott Street, in the Community of Chatham. Public Works has completed numerous repairs over recent years, including the repair of a sinkhole in the road caused by the failure of a sanitary service connection in the Fall of 2022. The Engineering and Transportation Division reviewed the existing sanitary sewers via Closed Circuit Television (CCTV) and confirmed that both the sanitary mainline sewer and the sanitary service connections are in poor condition and need to be replaced. Additionally, the existing storm sewer is of similar age and material as the sanitary sewer and will be replaced as part of this project to meet current standards. The existing 150 mm diameter cast iron watermain that was installed in the early 1960's has also experienced several breaks over the years and is due for replacement.

Furthermore, the poor condition of the asphalt pavement along Wyandott Street (average Pavement Condition Index of 33), makes it an ideal candidate for a full infrastructure replacement project. There are no concrete sidewalks present along this road segment and they will be considered for inclusion as part of this project.

The Request for Proposals focused on the procurement of consulting engineering and inspection services associated with the reconstruction of Wyandott Street from Chippewa Drive to Cecile Avenue. It is the intention that the consulting engineering be

initiated in 2023, and the construction and inspection services be initiated and completed during the 2024 calendar year.

## **Comments**

In accordance with <u>Purchasing By-law</u> #166-2020, the request for proposals were advertised on the municipal website on February 6, 2023 and closed on March 9, 2023. A total of fourteen potential consultants obtained a copy of the contract document from the Chatham-Kent Bids and Tenders website and nine proposal bids were submitted. The bid results and ranking are outlined in Table 1.

The proposal submitted by RC Spencer Associates Inc. illustrated the staffing resources, methodology and quality controls necessary to initiate and successfully complete this project. Based on the panel review process, the proposal submitted by RC Spencer Associates Inc. was deemed to be the preferred submission ranked highest by the panel.
