## Recommendation

It is recommended that:

1. The 2021 One Time Canada Community Building Fund (CCBF) totaling \$6,198,165 be allocated to the projects identified in Appendix A.

## **Background**

In early 2021, the Federal Government announced a one-time top-up to the Canada Community Building Fund (formerly the federal gas tax program) resulting in an additional \$6,198,165 funding to Chatham-Kent. The funds were welcomed as the Federal Government's commitment to supporting Municipal infrastructure priorities in the face of COVID-19. All funds are to be used in accordance with the Municipality's current agreement with the Association of Municipalities Ontario (AMO) for the transfer of these funds.

## Comments

Administration populated a list of projects that met the qualifying factors for this onetime CCBF allocation and concluded on the projects identified in Appendix A. Other projects that were considered and ultimately eliminated either already had:

- Outstanding grant applications pending,
- Not in a position to proceed (either with design or construction) due to additional studies or investigation required,
- Already proposed through the Municipality's Capital Plan or already has funding allocated to it.
- Already receiving federal funding.

In accordance with the AMO Grant Transfer Agreement, projects proposed in Appendix A were required to satisfy the following eligibility criteria:

#### Recreational Infrastructure – Recreational facilities or networks

- Large facilities or complexes which support physical activity such as arenas, gymnasiums, swimming pools, sports fields, tennis, basketball, volleyball or other sport-specific courts, or other facilities that have sport and/or physical activity as a primary rationale
- Community centers that offer programming to the community at large, including all segments of the population
- Networks or parks, fitness trails and bike paths

# <u>Disaster Mitigation – Infrastructure that reduces or eliminates long-term impacts and risks associated with natural disasters</u>

- Construction, modification or reinforcement of structures that protect from, prevent or mitigate potential physical damage resulting from extreme natural events, and impacts or events related to climate change
- Modification, reinforcement or relocation of existing public infrastructure to mitigate the effects of and/or improve resiliency to extreme national events and impacts or events related to climate change
