# **Background**

Section 242 of the Municipal Act states: "A municipality may, by by-law or resolution, appoint a member of the council to act in the place of the head of council or other member of council designated to preside at meetings in the municipality's procedure by-law when the head of council or designated member is absent or refuses to act or the office is vacant, and while so acting such member has all the powers and duties of the head of council or designated member, as the case may be, with respect to the role of presiding at meetings."

Section 11.2 of the Municipality of Chatham-Kent Procedure By-law 141-2022 states: "From time to time, the Mayor/Chair may be absent from the Municipality of Chatham-Kent or may be absent from the office through illness. In such instances, it is desirable to have an alternate designated to act in the place of the Mayor. The Clerk shall prepare a schedule by the first regular meeting of Council, listing a monthly rotation of the Members of Council to act in the absence of the Mayor for the duration of the term of Council."
