Subject: Network Infrastructure Lifecycle Projects

Recommendations

It is recommended that:

1. The planned lifecycle replacement of network infrastructure (core firewall) hardware with a total value up to \$50,000 be funded from the ITT LIFEAMP COMP NETWORK RESERVE (17686) and funds be transferred to 13846.39046.GEN.
2. The planned lifecycle replacement of data room Uninterruptible Power Supply (UPS) for technology systems at three locations: Civic Center, Riverview Gardens (RVG) and Health and Family Services (HFS) valued at \$70,509.20 (including HST) be funded from the ITT LIFEAMP COMP NETWORK RESERVE (17686) and funds be transferred to 13846.39046.GEN.
3. The planned lifecycle replacement of network infrastructure at Riverview Gardens; valued at \$130,450 (including HST) be funded from the ITT LIFEAMP COMP NETWORK RESERVE (17686) and funds be transferred to 13846.39046.GEN.
4. The planned lifecycle replacement of the Identity and Access system valued at \$44,500.54 (including HST) be funded from the ITT LIFEAMP COMP NETWORK RESERVE (17686) and funds be transferred to 13846.39046.GEN.

Background

The Reserves and Reserve Funds Policy was adopted by Council on September 14, 2021. The Policy states the following:

Contributions to/drawdowns from reserves and reserve funds shall be approved by Council as part of the annual budget process, or specifically, by resolution.

Comments

The Municipality of Chatham-Kent replaces network hardware infrastructure at regular intervals to ensure that network connectivity is stable, supported, and secure.

The core firewalls are components of the network infrastructure and are being replaced as part of a regular lifecycle plan.

Provision of functional UPS at Civic Centre, RVG and HFS will ensure network and application services are resilient and protected from data loss in the event of power failure and allowing server administrators to perform a controlled shutdown of network devices in the event of a prolonged power outage.

The current core systems infrastructure at RVG are past their lifecycle with some network component reaching their End of Life and now need to be replaced to support a continual operation of the network.

The identity and access systems are also obsolete, and an upgrade will bring about an improved security of access and identity management for staff accessing Municipality network and systems.
